*I wish to participate in the A+ Schools Program's student financial incentive at Lighthouse Preparatory Academy. If state funds are available and Lighthouse Preparatory Academy is redesignated an A+ School prior to my graduation, I may be eligible to receive reimbursement for the cost of tuition and general fees while attending a Missouri public community college or vocational-technical school on a full-time basis. This reimbursement will be for the unpaid balance after federal post-secondary financial assistance funds (that do not require repayment) have been applied. * This is on condition that I meet all the following requirements:*

- Be a U.S. citizen, eligible non-citizen or lawfully present in the U.S.
- Attend a designated A+ high school for 3 consecutive years prior to graduation.
- Graduate with an overall grade point average of 2.5 or higher on a 4.0 scale.
- Have at least a 95% attendance record overall for grades 9-12.
- Perform at least 50 hours of unpaid tutoring or mentoring, of which up to 25% may include job shadowing.
- Maintain a record of good citizenship and avoid the unlawful use of drugs and/or alcohol.
- Achieved at least one of these combinations of Math ACT Score & High School GPA:
 - 17 or higher on ACT Math test and 2.5 or greater High school GPA
 - 16 on ACT Math test and 2.8 or greater High school GPA
 - 15 on ACT Math test and 3.0 or greater High school GPA

The student financial incentive may be available for up to two (2) years of attendance during the four-year period after I graduate from high school. To maintain eligibility, I must:

- (1) Pursue a degree on a full-time basis at a participating postsecondary school.
- (2) Maintain a grade point average of 2.5 or higher on a 4.0 scale.

Note: The degree being pursued cannot be a degree or certificate in theology or divinity.

I further understand that this application and the Authorization for Release of Records from the Office of Juvenile Court Services must be signed by the applicant and parent/guardian before I will be considered for participation in the A+ Program Student Financial Incentive.
